Remote Learning

You will be aware that, due to the increasing infection and transmission rate of COVID-19 all learning will now take place remotely.

I apologise to our nursery parents who up until Tuesday 5 January were of the understanding that nursery would return on Wednesday 6 January. Due to the lack of information from DE by lunchtime on Tuesday 5th the Chair of Governors and I decided that in order to allow parents some time to arrange child care and to ensure the safety of all children and staff, nursery would not re-open until further information had been received from DE. This decision proved to be the correct one, as DE announced late on Tuesday evening that nurseries should also close.

We used Seesaw in the previous lockdown and also for homework since we returned to school in September. Seesaw lessons began on Thursday 7 January except for Y7 (AQE children) who will begin Seesaw on Monday 11 January.

Key Worker & Vulnerable Children Provision

While the children are learning remotely, school is still open in order to facilitate Keyworker and Vulnerable Children. The initial communication from DE stated that both parents should be key workers. DE have now clarified that one parent should be a key worker. However, given the extremely high rate of infection and transmission at the moment DE have advised that provision in school **SHOULD BE A VERY LAST RESORT. While I always recommend that children should be in school, I am 100% convinced that the safest place for children at the moment, is at home.** The children who attend will be facilitated in the Gym Hall and supervised by classroom assistants from 9.00am – 2.00pm. As stated by DE there will be supervised learning but there will be no face to face teaching. In order to limit possible transmission (keeping the children and staff as safe as possible), the children will be outside as often as the weather permits, classroom assistants will wear PPE and will maintain 2m social distance at all times. While we will encourage children to socially distance from each other, I'm sure that you appreciate that this is impossible with primary aged children. For the period of remote learning this group will become a 'bubble' and will be treated as such should any child or adult test positive.
